Dear friends in Christ,

Looking across the church, I am grateful for your generous giving of time, talents, and resources. Yes, This year has been a challenging one! The COVID-19 pandemic has changed the church and society. We have had to shift the ways we engage in ministry from a focus on in-person worship and meetings to livestream worship, virtual meetings, and gatherings in the parking lot. We have had to shift to teaching children at home and working from home. We have not been able to travel to see friends or relatives or to celebrate life events. This has also been a time to address economic and social justice issues, to shift our thinking and our way of life.

Dear Beloved in Christ of the Northwestern Minnesota Synod,

I am writing in the final days of 2020, a year we will be happy to put behind us! In Luke 2, old Simeon meets the baby Jesus and praises God, because in this child the long era of Israel's oppression was behind them and a new era of salvation was dawning. Yet the baby Jesus was, like all babies, all promise and no product. Simeon may have died a satisfied man, but had he lived 33 more years, he would have seen Jesus fulfill some promises... and leave others yet to be fulfilled. Now we live in "the time between." This is the time between the revelation of Emmanuel, God with us in all of life, and the time when Jesus "will come again to judge the living and the dead," bringing justice and healing to all. In this time, we walk with the faith of Simeon, thanking God for the salvation we have seen and trusting God for the salvation yet to come. Our Gospel work is also shaped by the "inbetween-ness" of these times. We are reassured by the countless ways that God has been faithful to us and to our church in the past, even while we trust that God will continue to show up for us in the daunting challenges we face in the future.

Please take a look at the enclosed/attached document which describes just some of the work we've been about as your synod staff this last year. This list is by no means comprehensive (that would be long, and possibly boring!). It's just the result of some brainstorming at one staff meeting last fall.

Since the start of the pandemic, I've understood our work to be keeping people connected, encouraged, informed and resourced. This has involved weekly and now semi-monthly virtual gatherings with rostered leaders, weekly and now monthly virtual meetings with congregation presidents, along with what has now become a vast collection of resources for church leadership in time of pandemic, COVID safety resources, virtual ministry resources, online worship services, etc.

This last year we've also been hard at work on our new strategic plan for the NW MN Synod. The plan flows from our vision: a people set free by the Gospel to be wholly devoted to Jesus and our neighbor in love. It is guided by our mission to foster safe and healthy places for the ministry of the Gospel to unfold and to shape an abundant future for all. It will focus on four lines of effort: vital small-membership congregations, leadership development, striving for justice and peace and responding to emerging change. Watch for more information on the strategic plan early this year.

Dear ones, thank you for your faithfulness in the Gospel! When the pandemic hit, you quickly adapted and found ways to share the good news in changed and challenging circumstances. Thanks also for your generosity that makes ministry happen, not only there in your congregation, but through your Mission Support, all across NWMN and around the world! Good work. Be encouraged: we are in this together.

♦ Prepared a virtual Middle School Gathering resource for congregations to use with youth groups, confirmation, or as a retreat in this unique time that we all are living in.

Are starting new worshipping communities in Moorhead with people experiencing homelessness, and in Bemidji with young adults.

Equip and encourage lay leadership through LIFE - Living in Faith Everyday (formerly known as the School for Lay Ministry).

Friends in Christ,

What a year it has been. I am so tired of saying "unprecedented" and yet it is the only word to describe this year. For us it has been unprecedented in more ways than just CoVid.

The year 2020 began with hopes for a continued successful trimester with Soul Food, a new staffing organization, and even a strategic plan in our conference. We were prepared for a year of change and growth, one that would focus on possibility and potential.

In February Jeannie Haukaas retired after nearly three decades of work with the Parish. We kicked off Lent expecting to dig into our commitment as disciples and asking the question, "why Jesus?"; then CoVid restrictions began. Suddenly the whole system of the world and our parish was completely off. There was no more sense of normalcy and only constant questions of "how do we do this" and "what will happen next?" Alyse Berggren stepped into a full-time role in order to get the office reorganized and archived; she served full time until August when she stepped back to part time work as a contracted employee. After many conversations and planning sessions with the Parish presidents and the personnel committee, two contracted job descriptions were written up- one for an office manager and one for a confirmation director. The confirmation director role was filled by Sam Lyon and plans were put in place to begin a new format for confirmation (see Sam's report for more details). Then Alyse died and the systems in the office that she was sustaining dropped off as well.

Thankfully, the office is now in the capable and caring hands of Calista Wolf. The parish spent the last quarter of the year trying to worship both online and in person, heading back to the parking lot for advent, and finding ways to bring some joy in the midst of struggle.

We all kept saying, "2020 is the worst, I can't wait until it's over." Now it's over and there is a light at the end of the tunnel, but we have a ways to go still. Psalm 126 is a guiding voice of reality and hope for me these days and I hope that it can be for you as well. The psalmist writes a song called "A Harvest of Joy"; it is a song that bears the weight of sorrow and the promise that sorrow will not win. Verse 5 says, "may those who sow in tears reap with shouts of joy." This year we have planted many seeds- resilience, flexibility, creativity, connection- but they were all sown with tears. These seeds were only planted because of global pandemic and death of loved ones, and yet they are seeds that we will be able to harvest with joy. We can see the light at the end of the tunnel, we know that 2021 will be different from 2020, and we will build and rebuild in this new year. Just as verse 1 says, when the Lord restores the fortunes, we will be like those who dream. This year we will pick up our dreams from last year, dust them off, decide if they still fit this new world and our new harvest. We will reinvest in our congregations, asking for God's direction and the Spirit's guidance so we too may sing "the Lord has done great things for us" and come home with shouts of joy, carrying the fruit of our labors.

### **Stewardship Report 2020**

The Northwest Minnesota Synod put together a team of pastors, lay leaders, and synod staff to organize and create resources for stewardship. These resources were geared specifically towards smaller congregations that didn't have a history of stewardship practices. The theme for 2020 was, "Lord, stir us to dream." As a member of the planning team, Pastor Birgitte decided to implement the program within the Parish. This was the first stewardship campaign in the parish in a very long time. A letter was sent out to our active member lists throughout the parish outlining the plan for the campaign. The third Sunday was set as the response Sunday in which members were asked to write down their financial commitment to their home congregation on an ornament, the commitments were kept confidential, and then hung on the Christmas tree at the front of our parking lot sanctuary. While there were not many responses this year, the campaign should be considered a success. We spent time together reflecting on stewardship and commitments to God and dreaming together of a future for the church. This was our first stewardship campaign, but it will definitely not be our last. We look forward to another campaign next year, one that will continue to lead us to ask, "Lord, stir us to dream."

### First Lutheran Church – 2020 Annual Property Board Report

### Lawn Maintenance:

Due to the dry summer the lawn only required one mowing per week, and occasionally once every two weeks. The mower is in good condition. We are grateful to the volunteers that assisted with the mowing. Recommend Property Board to consider spraying the lawn for control of dandelions in 2021 if approved.

### Insurance Inspection July 7, 2020:

Church Building, with the following recommendations completed:

1) Placement of basement stairway railing

2) Place a CO2 detector in the area of the furnace

3) Add "Adult Supervision" signage in the playground area (safety and liability)

4) Define/paint uneven sidewalk areas with yellow paint

### Church Security:

As a result of vandalism on the church grounds, two remote surveillance cameras were purchased for the front and the back of the church.

### Sunday School Wing:

The area was toured and assessed after cleaning the area for use during Soul Food. Removal of three old televisions and a broken ping pong table (a safety issue for unsupervised children who play in the area).

### Podium Project:

Reviewed podium options (refurbish, rebuild, new purchase) with member of the Kothrade family, and purchased a new podium in memory of Leila Kothrade. Contacted the pastor from the Covenant Church to seek information about a portable sound system that could be used with the podium, outdoors, and as a backup. Purchase was denied.

Rod Gubbels built and donated an alter which will be used for the Soul Food services. Rod also cleaned the basement, basement drain and drainage channels in an attempt to eliminate the problem of standing water in the basement and disposed of trash that had accumulated there.

Judy Gubbels spent approximately two weeks cleaning and organizing the archive room with much input from ELCA Archivist. There is still more to be done, but the project was interrupted due to COVID restrictions. Choir closet and practice area were also cleaned and organized.

After a fire on the playground, Rod Gubbels built and replaced the steps that had been burned.

Board discussions included the need to replace certain exterior entry door frames, doors, and weather stripping due to rust and air leakage. The Women of the Church are actively fundraising for this project.

Church Front Entry Safety: The City of Baudette is no longer providing salting/sanding services. A push/walk behind Broadcast Spreader was purchased to promote safety during icy conditions.

Now in the midst of winter, there is time to reflect on the sending message of Advent, when we prayed "Lord, stir us to dream." As we anticipate the 2021 growing season, we invite the congregation to continue to dream with us.

When this committee was formed in 2013, it began with a tiny seed of faith. Excited "gardeners" gathered to create a vision that grew to include features we hoped for on the church property, features that would extend our welcome beyond the sanctuary, spill out onto the beautiful church grounds, benefit not only our church family and our parish, but provide a gathering place for our entire community. *<u>Vision Statement</u>*: To develop and manage a cohesive and comprehensive strategic plan for a unified outdoor extension of our sanctuary.

### Goals and Objectives:

- To ensure appropriate location, configuration, appearance and maintenance of all features
- To establish a sense of enclosure and to define property boundaries
- To reflect a liturgical and sacred vision in every aspect of the project
- To assist the Property Board in continual assessment of the outdoor property and church grounds for improvement and maintenance needs
- To help determine feasibility and affordability of outdoor projects and to help coordinate fundraising when necessary or desired
- To oversee outdoor property construction projects and details from development through completion
- To improve and enhance our current church grounds

## The vision for the improvement of our church grounds is seen as an extension of our sanctuary, a sacred space, with a cohesive and unified design that reflects the style and appearance of our church.

In the early verses of Ephesians 4, the apostle Paul writes to the Christians in Ephesus, a city on the Aegean Sea at the mouth of a river and at the intersection of three trading routes. The letter was written about ten years after the church had started. During the early years of this congregation, Jews and Gentiles from several ethnicities and nationalities had come together to form "one body." Paul was aware that they had done well and commended them for their faith and love.

The word "one" appears more than seven times in the first four verses. This reflects the importance Paul gave to being called into the "unity of Christ." He wanted to note that, although many of the church members came from far off, there is "one Lord, one faith, one baptism." This oneness reflects God's gift of reconciliation in Christ.

A second emphasis from Paul was that, as believers, they were to "bear with one another in love." This would require humility, gentleness, and patience as each of them practiced their faith. It would require tolerance to "maintain unity of the Spirit in the bond of peace."

A third emphasis was that each person had been given gifts by God and that these gifts were given to increase the whole. Because the Ephesian church was a young congregation and its members were just beginning in their faith journey, their understandings were often tossed to and fro. But as they grew in faith, each person contributed to building up the body of Christ.

The fourth and final emphasis was that by "speaking the truth in love," each person must grow into Christ. This means taking time to learn about one another and their gifts. Knowing these gifts, we can do God's work both within and beyond the faith community. When there are decisions to make or relationships to reconcile, we know to begin with prayer and reflection, always desiring to speak the truth in love — not for our own benefit but for God's glory, that we might become more complete. As our members and friends gather today, whether face-to-face or online, we are reminded of our calling into "unity in Christ." We come from many places and work in many contexts, and yet we recognize "one Lord, one faith, one baptism."

Whether new to a worshiping community or further along the journey, we realize that humility, gentleness, and patience are required both in the good times and especially in times of uncertainty and struggle. God wants us to be more complete through our work. Christ provides the way. The Holy Spirit is with us for guidance and courage. Each of us has been given the gifts to be complete, and through our faithfulness we will grow stronger and work together as one body.

Let us pray: Lord. let the words of the apostle Paul dwell in us deeply. May we embrace the reconciling power of oneness with Christ. May this oneness guide our congregation as we live into the new realities of these times. As we meet new partners in ministry, may we take time to get to know them with patience, humility, and love. Help us to see how sharing our gifts will make your work easier and more fulfilling while bringing all of us closer to Christ. May the blessings you give each day strengthen us to a living, daring confidence in your grace. Amen.
